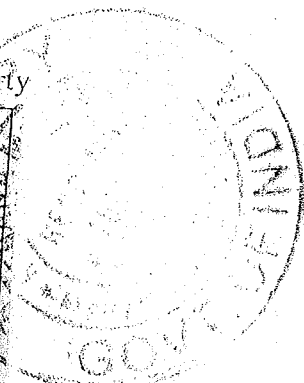

10. Permission for integrated posting & research project activates.

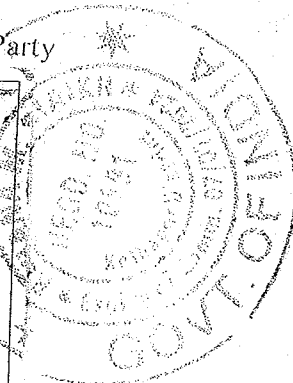
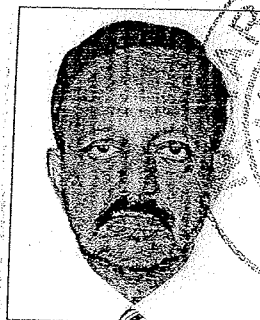

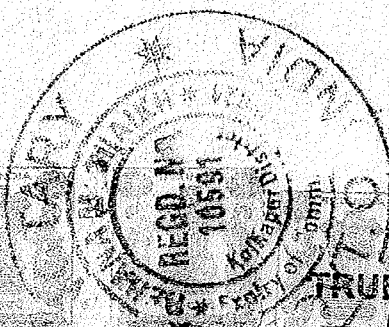
