UPPER GROUND FLOOR PLAN

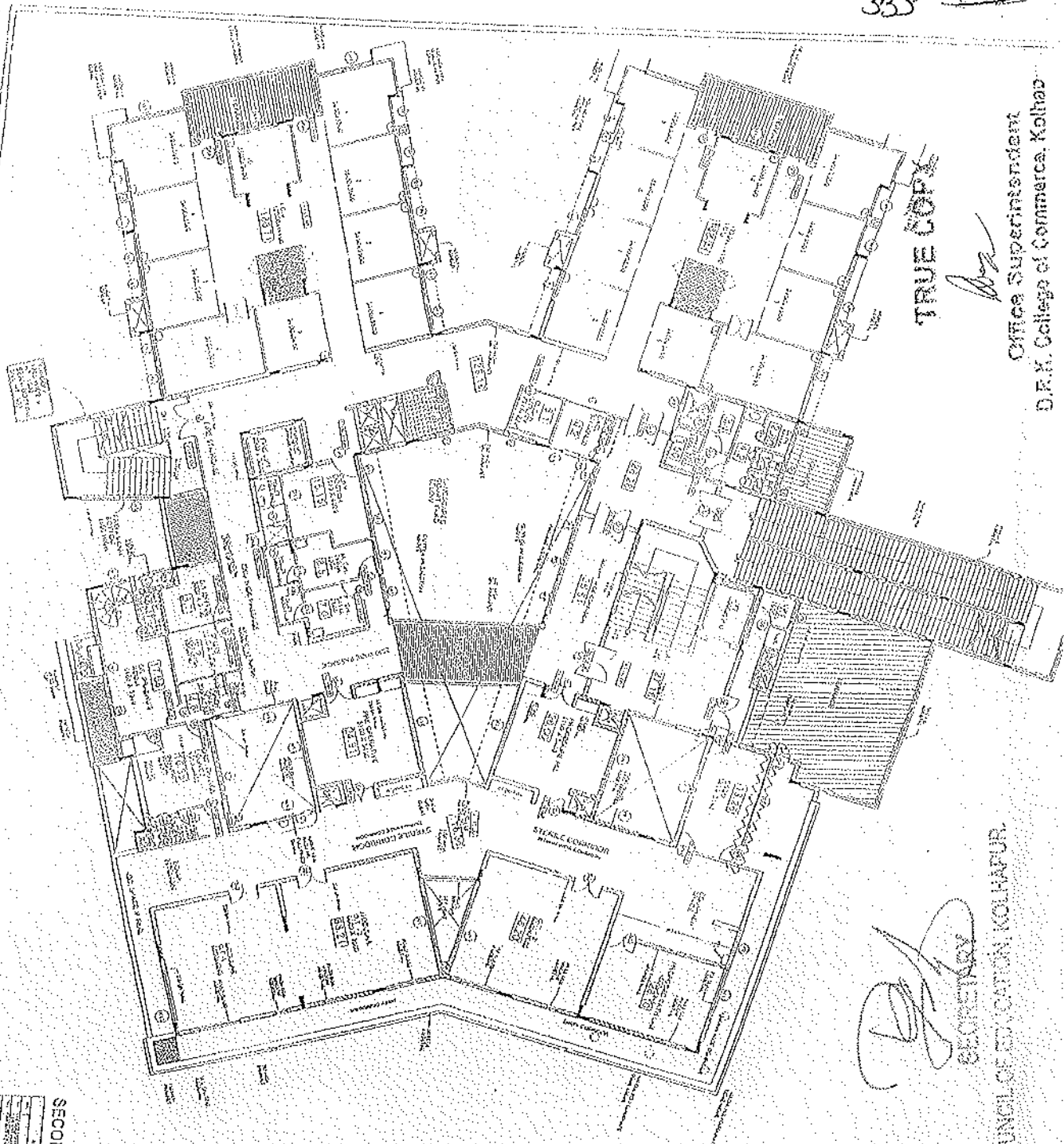
